# Annual Erosion Committee Report October 3, 2018

The members of the Erosion Committee are: Section 1: Michael Ryan Section 2: Don Creveling Section 3: Robert Anderson Section 4: Stephen Hult--Chair Section 5: Deb Ament

During the past decade the Erosion Committee has completed fourteen major shoreline restoration projects on the community's 3½ miles of shoreline. The projects have restored 5,690 linear feet — over one mile — of degraded and eroding community shoreline using ecologically appropriate living shoreline techniques. The Committee has won over \$420,000 in highly competitive State and Federal grants to help subsidize the cost of these projects. Granting agencies have included the Chesapeake Bay Trust, the National Oceanic and Atmospheric Administration and the National Fish and Wildlife Foundation. The South River Federation recently called named Glebe Bay as the "Best Looking" part of South River thanks to the living shoreline efforts of the London Towne Community.

This winter we will complete a large project to replace the deteriorating 250 linear foot bulkhead in Section 1. The project is scheduled to be done the "non-boating season" during the winter months in order to be minimally disruptive for boaters. We paid one half of the \$120K project cost in FY 2018 and will pay the remainder in FY 2019. The project will be done primarily from the water using barges and should take about 6-8 weeks. The actual bulkhead replacement is an LTPOA Erosion Committee project since its primary purpose is to protect the community shoreline. However, any needed repairs to the piers and the nominal cost of reconnecting the electrical and water connections will be the responsibility of the Section.

Consistent with our established practice and policy, the Erosion Committee has continued to work hand-in-hand with the Park and Planning Committee to maintain and improve our community parks and shorelines. We have continued our ongoing program of repairing any damaged shoreline areas and controlling invasive vegetation such as phragmites. We have also been encouraging the spreading of desirable species such as rose mallow and marsh hibiscus.

#### Public Water Committee Update, September, 2018

It is a long process that requires many steps, including surveying houses along the route. On our first survey we missed some houses (we received 53% approval as I recall) so we then had to walk the proposed route to ensure an accurate count. We now need to do the address envelopes and send out cards to all homeowners on the route. I have been stuck there for the last six months due to an extremely busy period at my job.

I need to call the committee back together and I will do that within the next four weeks. Unfortunately all of this has taken so long that some of the original committee members have drifted away.

## POLICE COMMITTEE- ANNUAL REPORT

## London Towne Property Owners' Association Inc.

#### OCTOBER 3, 2018

The Police Committee is responsible for addressing issues on the safety and security of Association property through hiring and scheduling security officers and acting as liaison between the Association and law enforcement agencies. Our security officers (Anne Arundel County police officers) continue to patrol the area to ensure that residents are safe and protected from unauthorized users of LTPOA parking, ramps, beaches, parks and other property. The following is a summary of the LTPOA Police activity during the last year:

Patrols: Completed 313 patrols

Hours: Conducted 1491 patrol hours

Warnings: Issued 78 written warnings and over 200 verbal warnings

Tickets: Issued 1 ticket for a traffic violation

Arrests: Made 2 arrests

Calls/Complaints: Officers responded to 28 calls made by LTPOA residents; Responded to 49 calls from AACO that were within our community

Other: Conducted 1414 property checks including the clubhouse; found the ramps gates open 6 times; towed 1 vehicle.

Police Officers patrolled and enforced LTPOA rules on July 4 and July 7 which resulted in the safe, orderly and enjoyable use of LTPOA property by residents and their guests. This was the third year for increased patrol during the holiday; again, with good results. We plan to continue with increased police presence on this holiday.

The Police Committee encourages anyone witnessing improper use or vandalism of LTPOA beaches, parks, ramps, parking areas and other property to please report to us.
