To Submit a Nomination (Deadline July 10, 2009):

When submitting a nomination, please provide the following:

- The award for which you are making the nomination.
- The name, address, and telephone number of the nominee.
- A short biography of the nominee and a description of his/her/their service to the community and/or Section Club.
- Your name and Section Club.

Clifford L. Schneider Award (One per year)

Presented to a past or present Board Member who has demonstrated outstanding service to the community and who has served on the Board of Directors for five consecutive years.

- Must have high attendance at Board of Directors and Section Club meetings.
- Must have donated time and supported functions and events through attendance.
- THIS IS A ONCE IN A LIFETIME AWARD

Outstanding Community Leadership Award (One per year)

Presented to a Board Member who has demonstrated outstanding ability to inspire service in others.

- Must have shown the ability to lead and/or inspired, initiated, or completed new or old tasks, programs, or projects.

Outstanding Dedicated Service Award (One per year)

Presented to any individual or committee for continued outstanding service throughout the community and/or a one-time effort.

- Has inspired or contributed toward the betterment of Londontowne
- Must have completed tasks for the community or single Section club.
- Must have donated time and/or made donations.

Good Citizenship Award (One per year)

Awarded to anyone in the community for displaying good citizenship and neighborliness.

- Helping others, donating time, or items to the community.
- Has done something to better the community.

Outstanding Business Award (Plaque, Maximum of two per year)

Awarded to an area business or organization for outstanding contributions to the community.

- Must have donated time, effort, donations, or gifts.
- Award must be chosen by the Events Committee.

Family Award (One family per year)

Awarded to a community family whose members have displayed dedication to the community through either a one-time effort or continuing efforts.

- Must have dedicated their efforts to the community. Other organizations are excluded from consideration.
- Must have completed a task for the community or Section Club.
- Must have donated time and/or made donation(s), or gifts.

**Section Club Honoree Award
(One per year per Section Club)**

A Section Club Honoree Award may be chosen by each Section President to honor a business or person, resident or non-resident, which has donated and/or contributed time to a specific Section Club.

**Outstanding Community Youth Award
(One per year)**

Awarded to a community youth (18 years or older) for outstanding service to the community through a one-time effort, or for long-time efforts, and/or involvement with youth organizations in inspiring other youths toward community service.

**Certificates of Appreciation
(Up to ten per year, residents or non-residents)**

Certificates of Appreciation are awarded to individuals or organizations for continuing service to the community.

**Youth Community Service Certificates
(Maximum of two certificates per year)**

Youth Community Service Certificates are awarded to youths (18 years or younger) for service to the community.

- Must have volunteered on several occasions for community work.

**President's Award
(Maximum of two awards per year)**

Chosen and awarded by the LTPOA President to a Board member who has shown outstanding service.
